The Swedish National Data Service (SND) is a National Unit at the University of Gothenburg (GU), instigated and funded by Vetenskapsrådet (Swedish Research Council). Vetenskapsrådet is the executive authority of the Swedish government in research issues.

As an organizational part of the GU, staff, equipment, technical infrastructure, as well as rules & policies, are to a large extent decided/managed by the University.

The scope of SND is formulated in a contract between Vetenskapsråden and GU and is monitored by a board/scientific advisory group appointed by Vetenskapsrådet.

SND has a national mission as a research infrastructure for the humanities, medicine & health and social science. SND preserves, promotes and disseminates digital research data for research and educational purposes.

SND is appointed as the Swedish CESSDA A/S Service Provider (SP) by the Swedish Research Council. SND is also part of Swe-CLARIN, the Swedish Service Provider for CLARIN ERIC.

SND accepts both quantitative and qualitative digital research data, and follows the OAIS reference model throughout the preservation process.

SND does not outsource any of the DSA guidelines.

SND provides information and guidance online about the process of depositing data at SND [1]. The depositor is requested to provide information about: publications based on the data, provenance and methodology used in collecting the data, and how the data have been managed, and possibly changed, over their life cycle [2]. Submitted data without appropriate contextual information is blocked at the ingest stage and the depositor is asked to supply the necessary information.

SND requests information about confidentiality issues in accordance with the Swedish Public Access to Information and Secrecy Act (Offentlighets- och sekretesslagen 2009:400), if the data include personal data in accordance with the Personal Data Act (Personuppgiftslagen 1998:246) and if data are subject to intellectual property prerogatives under the Act on Copyright in Literary and Artistic Works (lag [1960:729] om upphovsrätt till litterära och konstnärliga verk) or the Patents Act (patentlag 1967:837). Information about ethical reviews is also requested [2], [3].

While assessments of data quality are ultimately the task of the secondary analyst, SND attempts to gather enough information about any given study and its investigators to make quality assessments possible.

The SND Handbook (available in Swedish on the SND intranet) contains detailed information about the ingest process and also describes the qualitative, technical and legal criteria the data have to meet in order to be accepted to the Archive. Data depositors provide metadata through the “Deposit Form” [1] and by attaching related material like questionnaires, code lists, and publications or citations to publications where data have been used. The documentation provided by the depositors includes descriptive metadata, structural metadata and administrative metadata [2].

SND’s data managers check all the documentation and make sure that all required metadata are included. If key metadata are lacking, the data managers contact the data producer to obtain the required information. If the producer is unable to provide sufficient key metadata the study is not accepted.

The collected information forms the basis of the metadata record (catalogue page), which is searchable and made available in both Data Documentation Initiative (DDI) XML and MARC formats.

In the contract between the Research Council and University of Gothenburg it is stated that the university shall have a succession plan prepared. In the event of the closure of SND the University of Gothenburg takes responsibility for all assets and staff.

In 2013 Sweden became member of the CESSDA A/S, for which SND is the Swedish Service Provider [3]. In 2014 Sweden became member of CLARIN ERIC, and SND is an A-centre within Swe-CLARIN [4]. These assignments comes from the Swedish Research Council.

SND promotes digital archiving through various activities, printed matter and web pages.

SND is a National Unit at the University of Gothenburg which is owned by the state.

All data depositors sign a Deposit Agreement with SND [1].

All data users agree to Terms and Conditions for Data Use [2].

In case of misuse, SND can ban the user from further access to data, and notify the user's home organisation and research funders of the breach.

Knowledge and compliance with national and international law, such as the Swedish Public Access to Information and Secrecy Act (Offentlighets- och sekretesslagen 2009:400) and the Personal Data Act (Personuppgiftslagen 1998:246) is ensured by internal training and counseling. SND employs a legal advisor (20% FTE).

Data with disclosure risk is handled appropriately. The depositor is asked about sensitive information and licensing issues concerning the data set. All data are reviewed by SND staff for disclosure risks and, when necessary, modified in consultation with the investigator. SND's Internal Handbook describes anonymization procedures in detail.

Data at SND are stored and distributed according to the Regulation for IT-Security at University of Gothenburg [3].

As a unit at the University of Gothenburg SND has to adhere to the policies and rules of the University, especially the 'Regulations for IT security' [1] which covers all aspects of data storage.

SND use storage facilities managed by the University's main IT service, which includes backups, recovery, security (secure server rooms, fire proof backup storage, etc.).

Data handled by SND falls within types 1 and 2 in the GU Information Classification (see chapter 2.2 in Regulations of IT security) and is managed according to regulations stated in the document.

The intranet based handbook "SND Handboken" contains detailed descriptions of the work flows.

The staff has adequate education in social sciences or humanities or health sciences.

SND accepts both quantitative and qualitative digital research data from SND's designated user groups and the work flows conforms to these types of data.

Upon signing the agreement (contract) the data producer is supplied with information about how SND manages the deposited research data (text file only (in Swedish and English), a copy can be provided on request).

All metadata are published in the SND Catalogue [2]. The SND Catalogue offer both simple and advanced search down to question and variable level. Study descriptions are available in Swedish and in English. OAI harvesting and deep search are available.

SND ensures that all of its data are usable and are identified uniquely. SND provides data with Digital Object Identifiers (DOIs) as well as downloadable data citations for use in publications based on analyses of the data [3].

## 11. The data repository ensures the integrity of the digital objects and the metadata.

At present SND is not using checksums. Both BagIt and Fedora Commons are evaluated and tested as solutions for an upgrade of the archive workflow. Both applications include usage of checksums.

Each study is processed by a data manager. All changes made by SND to a SIP to create an AIP to allow digital preservation are documented by SND data managers. Complete information about each data and metadata file as well as change logs and additional administrative metadata are stored in SND's internal management system (SIMS), and certain information is also published with the metadata.

All versions of data archived are saved. Version changes are manually logged in SND's management system and new versions are assigned a new DOI.

- Major version change: Changes in the dataset matrices (the datasets have a different number of units, variables and/or value categories).
- Minor version change: Changes in the documentation of the dataset.

By default, SND provides access to the most recent version of the study. For earlier versions, users must contact SND. Version number of the study is part of its citation [1].

SND identifies the Submission Information Packages (SIPs), and data managers work according to the SND Handbook about the content of the Archival Information Packages (AIPs). The Dissemination Information Packages (DIPs) are both manually and automatically constructed from the AIP. SND uses the DDI metadata standard for documenting data.
